H. NEW BUSINESS -

 Receive update on the Acacia Park Project. (Fiscal Impact: None)
 Meredith introduced Cheryl Ebert from the city's Public Works Department and Greg Meek from RHA Landscape Architects.

The project is moving along and construction is anticipated to begin in May with completion scheduled for mid-August. As recommended to City Council by the Commission, the project will not include a pool or restrooms.

Meredith Petit and Greg Meek reviewed the park and playground design drawings for the project.

Christopher Hentzen gave a presentation on the progression of the Summer 2019 Brett Field renovation procedure. He shared soil sample findings and options to possibly improve the field condition going forward.

BACKGROUND & DISCUSSION:

In early 2019, the City Council supported the allocation of rental space to four primary youth aquatics clubs at the El Segundo Wiseburn Aquatics Center: Alpha Aquatics, Beach Cities Swimming, South Bay United Water Polo, and Trojan Water Polo. As a result, the City Council directed staff to determine methodology to measure success of the those groups to ensure the service providers are providing programs that align with the goals and objectives of the City's aquatics vision. To that end, staff has used a collaborative approach working with the user groups to establish what is reasonable and feasible to achieve that outcome.

On September 5, 2019, the Directors for the four youth teams met with the Director of Recreation and Parks, the Recreation Superintendent and the Aquatics Supervisor to discuss various ideas for measuring success. The group understood the goals for the City to establish success criteria to be used as a gauge to establish desired and best practices for rental groups to ensure that they are providing service that is beneficial to the El Segundo community. On December 2, 2019, the Aquatics Subcommittee (Vice Chair Davis and Commissioner Watson) met with staff to review the proposed criteria. After careful consideration and conversation, the Aquatics Subcommittee opted to make some small adjustments by adding a self-assessment, a required quarterly report and establish an El Segundo residency goal for all groups. Listed below, are the primary Criteria for Success.

Part I:

Self-Assessment

Groups are required to describe their successes and organizational goals on a local, regional and national level annually. They will also submit a quarterly report which will include updates and/or highlights about their organization and participants.

Part II:

Adherence to facility procedures and guidelines

Groups must ensure that the coaches, participants and spectators act responsibly and follow the facility rules at all times. Groups must remain in good standing, ensure their insurance requirements are met, keep their non-profit paper work on file and up to date, foster positive relations with staff, and assist in maintaining a clean and orderly environment at the Aquatics Center.

Community Benefit

There are a variety of possibilities which will fulfill this benchmark. Organizations offering community scholarships, participating in fundraisers or collaborative events with other teams are suitable activities. Teams can also choose to collaborate with the City of El Segundo, ESUSD and/or WUD on an event as long as it is beneficial to the community.

Financially Responsible and Adherence to Requested Times and Dates

Ensure all payments are made in a timely manner and lane cancellations are made within the proper 2 week notice.

Lane and Space Utilization

This criteria requires the organization to use the rented space responsibly. Success will be defined as each lane rented filled with at least $\underline{2}$ swimmers per lane in short course and $\underline{3}$ swimmers per lane in long course.

Resident Participation

Resident participation will be defined as 20% percent of active participation for a rental group within a given period of time.

Example: Success would be defined as 20% resident participation by August 2021. An evaluation of each groups El Segundo residency will be done in June of 2021.

The Aquatics Subcommittee, directors of the youth clubs and staff met again on the evening of December 2, 2019, to discuss the proposed criteria and additional requirements. All attendees were allowed to ask questions and make comments which were considered in the final proposal. It is important to note that the results of each groups' measurements are not intended to be compared to each other for ranking purposes, rather to show an independent review of each group's progress towards the City of El Segundo's goals and objectives.

Furthermore, due to the facility being in its first year of operation, the Aquatics Subcommittee and staff are recommending to extend the existing contracts with the current user groups through August 2021 to give all groups ample time to show growth and progress under these new guidelines.

Should the Commission concur with the Criteria for Success and recommendation from the Aquatics Subcommittee to extend the group contracts, the Department will move forward to present the information to City Council with a comprehensive 1-Year Report for the facility.

City of El Segundo Criteria for Success

I. Introduction

The Recreation and Parks Department takes great pride in working for the community. The department has its own established core values and focus to ensure that we continue to keep striving for the best service and value that we can offer to our customers. Community involvement that benefits El Segundo residents is an essential component to the operations at new aquatics center. Regardless of the proposed use, educational and other community programs will be critical and a key element of the evaluation process. Recreational programs, teams, special events and/or other activities that foster increased participation from all residents and visitors will be important.

II. Recreation and Parks Values, Motto and Mission

The Recreation and Parks department recognizes the following as our Values, Motto and Vision:

A. Values

- **Community** Having a feeling of fellowship with others
- **Diversity** Accepting and appreciative of differences
- Fun- Enjoyment, pleasurable, entertaining
- Innovation- Original and new thoughts, creativity, "Where Big Ideas Take Off"
- Integrity Honesty, strong morals, of good character
- Quality- The attribute of high or excellent
- Teamwork- Reaching goals together with good intent
- Tradition- Recognizing and respecting customs or past practices

C. Vision

"El Segundo Recreation and Parks strives to be a heart of community wellness by offering people of all ages the opportunity to enjoy engaging experiences within our parks and facilities."

These key concepts are very integral to our department and should be equally important to any and all groups desiring to collaborate with El Segundo Recreation and Parks. The City of El Segundo also has overall values and work culture which naturally feed into all operations throughout the City. Major focuses for this specific collaboration will be the City's values of *productivity, ethics stewardship and service.* Along with a working culture qualities of *innovation, leadership by example and proactive action*. The City also has a distinct desire to be fiscally responsible and in doing so, has the expectation to generate revenue to show adequate cost recovery.

III. Criteria for Success

Given all of the above each rental group will evaluated annually based on their ability adhere to and promote the ideals listed above in accordance with the two parts listed below.

Part I:

Self-distinguished successes and organizational goals on a local, regional and national level. To be evaluated annually as to the organizations progress in attaining their goals.

Part II:

- 1. Adherence to facility procedures and guidelines
- 2. Community Benefit
- 3. Financially Responsible and Adherence to Requested Times and Dates
- 4. Lane and Space Utilization
- 5. Resident participation

IV. Criteria Defined and Definition of Success

Part I:

Self-Distinguished successes and Organizational Goals

Each group is to fill out the attached form and address the questions in 2 pages or less:

- 1. What you consider to be your organization's current successes on a local, regional and national level.
 - i. Further broken down by age group/division.
- 2. Please provide any supporting data from any and all outside sources to illustrate your successes.
- 3. And finally please outline your organizational goals on a local, regional and national level that you believe will contribute to your organizations viability, growth, and success.
- 4. Annual Self-Assessment

Part II:

A. Adherence to rental terms and conditions as defined in Section VI.

Groups must ensure their coaches participants and spectators act responsibly and follow the facility rules at all times. Groups must remain in good standing, ensure their insurance requirements are met, keep their non-profit paper work on file and up to date, foster positive relations with staff, and assist in maintaining a clean and orderly environment at the Aquatics Center. (See Section VI for Specific Terms, Conditions and Facility Rules)

Success would be adherence to RENTAL TERMS AND CONDITIONS as mentioned in section VI.

B. Community Benefit

Could include anything from offering community scholarships, fundraising, collaborative efforts between the teams and the City of El Segundo, ESUSD and/or WUD on an event that would directly benefit a community program/school or address a community need. Examples could be developing a swim clinic for ES Elementary school students to learn to swim (ie: an everyone learns to swim initiative type program event, or a collaboration with teen center programs/camps etc. that would be free for ES Residents or Wiseburn residents/students etc...)

C. Financially Responsible and Adherence to Requested Times and Dates.

Ensure all payments are made in a timely manner and lane cancellations are made with in the proper notice. And all time requested is paid for in a timely manner.

Success would be defined as completing all payments on time and ensuring that the times and dates were requested were utilized.

D. Lane and Space Utilization

To ensure the pool space is used responsibly daily counts will be taken every half hour. These numbers will be compiled monthly to ensure groups continue to utilize the space given in a responsible manner. Success would be defined as each lane rented filled with at least $\underline{2}$ swimmers per lane in short course and $\underline{3}$ swimmers per lane in long course.

E. Resident Participation

Resident participation will be defined as the percent of active participation for a rental group within a given period of time. Active participation will be tracked through the implementation of a "scan upon entry" system in which each participant for a given group will be required to create a scan card, which they will be required to scan in order to gain access to the facility. Residents will be tracked through this system and will be required to show 2 proofs of residency.

Success would be defined as 20% resident participation by August 2021. An evaluation of each groups El Segundo residency will be done in June of 2021.

Aquatics- January

Highlights over the last month in Aquatics:

- We have 4 new staff that are just awaiting their City Hall Orientation and 11 additional staff going through fingerprinting, physical and TB tests.
- The Plunge was able to host the first round of winter lessons.
- While not at our maximum potential- with the staff back from school and the three new hires we were able to offer more swim lessons this winter.
- Public Works did an amazing job clearing the drains, repairing the AC and repairing our broken tiles. Public Works was also able to adjust the mixing valves within the showers and sinks and our patrons now have much warmer water!
- From last month the Aquatics center numbers have increased! The drop ins alone is up 170 over last month as we are getting new spurts of warmer weather.

Issues over the last month in Aquatics:

• The Plunge has been struggling to get back on its feet with Lap Swimmers. There was a slight boost in the AC "drop in" numbers which may account for Plunge lap swimmers that moved over during the holiday closures and have yet to return to the Plunge. We will need to monitor that and see if they begin to trickle back to the Plunge.

New Programs/Events on the Horizon

- On February 14th the plunge will host a dive in movie to celebrate the holiday! We will be playing the Little Rascals
- We met with Senior Guard staff to delve into the new lesson formatting. We will be publishing the revised level descriptions on the new website and in civic rec by the end of February!


SUBJECT: Department Status Report

El Segundo Recreation & Parks



Staff is working in partnership with **Raytheon** for the public use of their Employee Park off of El Segundo Blvd. for the Spring AYSO season. The goal of the partnership is to build a positive working relationship with the corporation to allow public access that could help relieve some of the pressure from the high demand on the City's fields due to growing user groups and increasing requests for space.

The new parking lot adjacent to **Richmond Street Field** is nearly completed. The City and ESUSD are working collaboratively to ensure the natural turf areas of the field are properly restored to the same condition as before the construction. There is still irrigation, grading and seeding/sodding to be completed, and that portion of the field may be playable in approximately 2-4 months.

Aquatics Recreation Supervisor **Jeannine Houchen** has announced that she has accepted a position with the City of Culver City and her last day with El Segundo will be February 26th. Jeannine has helped the Department continue to build strong policies and procedures at the El Segundo Wiseburn Aquatics Center and we thank her for her contributions to the Department. The Department intends to utilize the current Recreation Supervisor recruitment from the vacancy at the Clubhouse to fill both Recreation Supervisor positions.
