#### **BACKGROUND & DISCUSSION:**

On May 15, 2019, the Recreation and Parks Commission reviewed and updated the prioritization list for recommended Capital Improvement Projects (CIP). The CIPAC (Advisory Committee) then ranked the projects against other city department requests and made funding recommendations to the City Council during the budget workshop for the 2019/2020 CIP program. Most of the parks projects rated as "High Priority" by the Commission were funded and several have been completed (Attachment #1).

During the budget process the City Council allocated \$800,000 to upgrade the Teen Center Complex, and on February 18th authorized staff to solicit for consultant services to conduct a needs assessment to help define a concept for upgrades to the Teen Center Complex. The Teen Center Complex is a 0.55-acre site that contains the following three uses: 1) a 5,480 square foot Teen Center building; 2) Outdoor basketball court; and, 3) Outdoor Skate Park (Attachment #2).

Because there has been a drop in participants and program at the Teen Center, and an increase in use at the Skate Park, it was determined that a more strategic approach to the project would be to evaluate the community needs and develop a scope of work aligned with the determined needs of the community. The Needs Assessment may also provide helpful information and data as it relates to other parks and recreation facilities and amenities, including the George E. Gordon Clubhouse and the Joslyn Center. The City Council directed staff to proceed with an RFP to solicit consultant proposals to conduct a Needs Assessment; however, due to the current state of affairs as a result of the Coronavirus pandemic there has been a delay in proceeding. It is now anticipated this could resume around September of this year.

Additionally, and also as a result of the pandemic, the City is facing unknown financial impacts as we prepare the next fiscal year's budget. The Public Works Department is recommending to not identify any new capital improvements projects for the upcoming fiscal year, but rather continue to work on already-funded projects that have not yet been completed (Attachment #3). Recreation & Parks projects in progress include the conceptual design of the future Plunge renovation, Acacia Park, softball field bleachers, the Gateway Project and inline hockey rink repairs.
