Bylaws

ARTICLE I

Name

The name of this organization shall be the Recreation and Parks Commission otherwise known as ...

ARTICLE II

Purpose

The purpose of the Recreation & Parks Commission is to advise the City Council on all matters pertaining to recreation, parks, parkways and street trees. The Committee is a standing advisory committee that serves at the behest of the City Council.

ARTICLE III

Qualifications

Members of the Recreation & Parks Commission shall be representatives of the community and must be residents of the City of El Segundo.

ARTICLE IV

Membership

The Recreation & Parks Commission shall be composed of a minimum of five (5) voting members and a maximum of ____(X) voting members. Candidates for the membership are reviewed and recommended by Recreation & Parks Commission and then approved and appointed by the City Council. Recreation & Parks Commission membership is limited to the residents of El Segundo.

The purpose of Recreation & Parks Commission is to make recommendations to the City Council regarding level of service, policies and assists in implementing Recreation & Parks Department improvements and programs, including youth counseling, senior outreach, golf operations, City transportation, and acquisition and disposal of park property..

The City Council shall appoint two (2) members of the City Council to serve as liaison members to the City Council and shall have no voting rights. (?)

Section I- Selection of Members

The City of El Segundo shall advertise and solicit applications to fill any vacant positions that may occur. After the application period has closed, the Chair, Vice-Chair and one (1) other

member of Recreation & Parks Commission shall review the applications with the sole purpose of selecting candidates for interview. After interviews are completed, the Chair, Vice-Chair and selected Recreation & Parks Commission member will recommend choices to the Recreation & Parks Commission for recommendation. The A Recreation & Parks Commission with then recommend candidates to the Mayor and City Council. The City Council will have the final approval and appoint the candidates. A candidate may not serve on the Committee without City Council final approval.

Section II- Term of Office

The term for Recreation & Parks Commission members is four years without term limits.

Section III- Compensation

Commissioners serve with minimal compensation of

Section IV- Removal

Members are expected to attend all meetings. When a member has three or more absences in a 12-month period, the Recreation & Parks Commission shall forward this information to the City Council for review and possible removal of the member.

ARTICLE V

Meetings

All meetings shall be open and public pursuant to the Government Code of the State of California.

Section I- Regular Meetings

Regular Meetings of the committee shall be monthly on the 3rd Wednesday of the month at 6:00pm.

Section II- Special Meetings

Special Meetings of the Board may be held at any time upon the call of the Chair or by the majority of the voting members or the City Council following at least 48-hours' notice to each member. The Chairman or a majority of the Recreation & Parks Commission shall determine the time and place of the Special Meeting.

Section III- Study Sessions/Workshops/Seminars

The Recreation & Parks Commission may be convened as a whole or as a committee as a whole in the same manner as prescribed for requesting a special meeting for the purpose of holding a workshop, study session or attending a seminar. No official action can be taken and a quorum is not required.

Section IV- General Meeting

At its regular meeting in [INSERT MONTH] of each year, Recreation & Parks Commission members will elect chair and vice-chair as well as discuss any other long term initiatives for the year.

Section V- Quorum

A majority of the Recreation & Parks Commission shall constitute a quorum. A quorum is necessary for action by the Recreation & Parks Commission.

Section VI- Voting

Each member shall have one vote.

Section VII- Meeting Procedures

Except as otherwise provided by these Bylaws or City Council Resolutions the Recreation & Parks Commission will follow the latest edition of Robert's Rules of Order for the orderly conduct of meetings.

ARTICLE VI

Officers

Officers of the Recreation & Parks Commission shall be a Chair and a Vice Chair. Term of Chair and Vice Chair shall be for 1 year. Duties of the officers shall conform to the regular parliamentary duties as set for by Robert's Rules of Order unless otherwise stated.

Section I- Chair

The chairperson shall preside over the meetings of the Recreation & Parks Commission.

Section II- Vice Chair

During the absence, disability or disqualification of the Chair, the Vice Chair shall perform all of the duties and be subject to all of the responsibilities of the Chair. The Vice Chair shall succeed the Chair if he/she vacates the office before the term expires. A new Vice Chair shall be elected at the next regular meeting.

Section III- Duties of the Recreation & Parks Commission

It is intended that the Recreation & Parks Commission shall be an advisory body to the City Council. Nothing herein contained should be construed as a limitation on the power of the City Council or the administrative staff of the City in their supervision or authority over property or personnel under their jurisdictions.

ARTICLE VII

Official Documents

Section I- Minutes

Minutes of all meetings should be prepared and maintained with the Recreation & Parks Commission records. Copies shall be distributed to each Recreation & Parks Commission member, City Council Member and City Clerk.

Section II- Distribution of Documents

Preparation and distribution of Recreation & Parks Commission documents to the members, City Council and City Clerk shall be the responsibility of the designated employee as identified by the City Manager.

ARTICLE VIII

Conduct of Members

Section I- Representing the Recreation & Parks Commission

Recreation & Parks Commission members shall make no personal commitment to speak on behalf of the Recreation & Parks Commission, nor make any statements or take actions representing the Recreation & Parks Commission, without majority approval.

Section II- Conflict of Interest

Members of Recreation & Parks Commission shall abstain from participating in any matter to come before the Recreation & Parks Commission in which he or she has any direct or indirect economic interest. Should conflict of interest exist, the Recreation & Parks Commission member shall remove himself/herself from discussions and abstain from voting. A yearly Conflict of Interest Statement shall be filed with the City Clerk.

ARTICLE IX

Assistance of Staff

The City Manager of the City of El Segundo shall provide the Recreation & Parks Commission with such information and staff assistance as the Recreation & Parks Commission may from time to time have requests; subject to the limitations imposed by City Council. The staff member designated by the City Manager shall attend meetings of the Recreation & Parks Commission and submit reports as needed.

ARTICLE X

By-Law Amendments

These Bylaws as well as any operating procedures may be amended by simple majority of those voting at any legal meeting of the Recreation & Parks Commission. Such amendments must be approved by the City Council.

Teen Advisory Committee (TAC)

The TAC held their second meeting of the year at the Teen Center on Monday, February 7. This was the first time the 2022 TAC was able to meet in-person, so they took part in additional introductions and icebreakers. Additionally, they finalized the details of their first 2022 event which took place on February 12.

On February 12, the Teen Advisory Committee hosted a bonfire in Recreation Park for teens in the community. S'mores, games, music, and the fire were provided for free. Over 30 teens participated in this first event.

Teen Center

The Teen Center continues to be staffed and open for drop-in use 6 days per week. Throughout February, an overall of 3,066 teens visited the Teen Center and Teen Center Basketball Court based on the hourly attendance added up for each day of month

The annual Teen Center Snow Trip took place on February 27. 20 teens were taken to Snow Summit in Big Bear, California for a full day of snowboarding and skiing. The trip was a great success with great weather, smooth travels, and no injuries.

Clubhouse and Classes

The Clubhouse and its various rooms were reserved/activated a total of 78 times in February for recreation activities and camps, Co-op, meetings, and rentals.
