Hi Ryan -

I understand this Thursday October 27th the planning commision will be considering whether to allow permanent home sharing in El Segundo and formulate a recommendation to city council. I spoke to you a bit about this at Bill and Carol Watkin's meet and greet, sharing that my husband and I have been home sharing through Airbnb since 2016. We have since registered with a permit number, business license, and pay our TOT every month for the duration of this pilot program. It has been a very smooth process.

We spoke about how Airbnb can actually streamline the process with the city, should the city work with them, thus allowing Airbnb to collect the TOT and also set the listings of whole homes to 30+ days and not short term. As I understand it, this automation would eliminate the need to pay a company such as Granicus for compliance monitoring and enforcement, thus allowing the TOT collection to be more profitable for the city. Malibu and Santa Monica both work with Airbnb to collect TOT, below is the link to the Malibu site for more information.

We sincerely hope the Planning Commission recommendations to City Council are to continue home sharing in El Segundo, and that City Council continue the program. As I understand it, there have been virtually no complaints since the pilot program was implemented last October.

I vet my guests and have many rules that are always enforced. I am writing in favor of Short term rentals to continue in El Segundo. Party houses are NOT the model for airbnb and we good host are providing safe places for family members of residents to stay and workers that commute to El Segundo. We now pay the TOT tax so there is money coming to the city and the city is regulating who can host. We have lost over a half of the short term rentals and the city residents need options for their family members to visit If the city doesn't allow the continuation of Short term rentals, I will be forced to sell my home. My Short term rental is the only income I have and I provide safe accusations for guests and an option for them. They eat, shop and enjoy our city. I am almost exclusively renting to family members that visit El Segundo residents.
