The use of city owned buildings for filming will be considered on a case by case basis. Fees will be determined by the City Manager or City Manager's Designee.

*Working around their normal schedule, police and fire personnel work film details on overtime basis. Due to possible conflicts with work schedules, film companies should attempt to schedule work hours 7 days in advance. The police department may require supervisors to work if more than 3 officers are working at the same time. Work schedule cancelations by the production company within 24 hours of the scheduled filming hours will incur a 4 hour minimum charge for each officer involved (to be deducted from the permit fees).

The number of officers required is determined by the police department. All police personnel scheduling will also be coordinated through the police department.

Fees are estimated in advance and actual costs will be calculated when the project is completed.
