Hyperion Water Reclamation Plant January 2023 Update

The Hyperion Water Reclamation Plant has completed various activities within the past month to continue the improvements and maintenance of the wastewater treatment processes. We are happy to share details of this important work, which can be viewed below along with website links for additional information.

Hyperion staff has installed new covers on all four tanks at Primary Battery A. Crews are now repairing Primary Battery C, with Primary Batteries B and D to be repaired soon after.

LASAN has made or is in the process of making improvements to address odors at the plant, with an investment of over \$114 million.

The Board of Public Works recognizes the urgency to address odor emissions and has directed LASAN and the Bureau of Engineering to complete projects by June 2024 (cutting the construction timeline by half its estimated duration).

Odor Control Improvement

As of December 7, 2022, LASAN has installed three continuous fence line monitoring systems located at the eastern boundary of Hyperion and the City of El Segundo. Information about these systems and their results can be found in the link below.
