SPECIFIC PLAN UPDATE BOUNDARY












OVERVIEW OF MARKET DEMAND (PROJECTIONS THROUGH 2040)

Land Uses	Proposed Project
Retail and Restaurant	130,000 square feet
Office	200,000 square feet
Medical Office	24,000 square feet
Residential Units	300 dwelling units

CEQA Process

- Notice of Preparation (NOP) Public Comment Period (January 12 - February 13, 2023)
- Draft EIR In Preparation
- Draft EIR Public Comment Spring/Summer
- Final EIR Late Summer 2023
- Public Hearings Late Summer/Fall 2023



Specific Plan Process

- ▶ Began in late 2021
- Public Workshop held June 28, 2022
- Online Community Survey conducted June/July 2022
- Planning Commission Study session held November 10, 2022
- Draft Specific Plan In Preparation
- Draft Specific Plan Available for Public to Review April 2023



Opportunities for Public Input

- ▶ NOP Public Review Period ends February 13, 2023
- Draft Specific Plan no specific review period, City welcomes feedback
- Draft EIR 45 days
- City Planning Commission Public Hearing
- City Council Public Hearing
