# **MEETING MINUTES**

Friday, April 7, 2023, 12:00 p.m.

#### CALL TO ORDER

The meeting was called to order at 12:03pm, held in the Executive Conference Room of City Hall in person.

### 2. ROLL CALL

The following Committee Members were present:

Councilmember Ryan Baldino was not present.

- 3. PUBLIC COMMUNICATION: A resident expressed concern over the idea of Scattergood shipping-in hydrogen for their proposed hydrogen plant. She referenced a study that indicated many reasons as to why it was not a good idea for the surrounding communities. Craig Cadwallader from Surfrider Foundation introduced himself to the committee and gave a background on his environmental work in the South Bay. He stated that he is interested in working with the City to get new ordinances passed such as bans on outdoor smoking, poly-styrene, and single use plastic beverage bottles. He asked for this to be considered on the Committee's Environmental Work Plan.
- 4. SPECIAL PRESENTATION: Staff from the Los Angeles Department of Water and Power (LADWP) gave a presentation on the Scattergood Modernization Project which will convert their Scattergood power plant to operate on renewable energy. They shared that they are currently operating at 45% renewable energy, but are reaching for a goal of 80% renewable energy by 2030. The LA100 Renewable Energy Study researched 4 different scenarios and found that Green Hydrogen was the most viable technology to reach this goal. LADWP staff added that the Scattergood Modernization Project would benefit the surrounding residents as it would significantly reduce NOx emissions and other particulates. The next step of the project is the CEQA review, where there will be several opportunities for public input. Member Butler expressed concerns regarding the amount of construction that will be needed in order to accommodate the transportation of Hydrogen to the plant. Multiple members expressed concerns regarding the continuous transportation of hydrogen through and around the community.

#### 5. REPORTS: PUBLIC WORKS

a. Hyperion Update: Director Sassoon provided a status report regarding Hyperion. He reported that the City is having better communication with the City of Los Angeles regarding Hyperion. He also mentioned that the Hyperion Citizen Forum will take place on 4/20/2023 via zoom. Further, Director Sassoon mentioned that

the LA Regional Water Quality Control Board fined Hyperion \$21.7 million dollars for spills, odor, and permit violations. Chair Miller-Zarneke expressed concerns about where the money received from these fines will go. Director Sassoon stated that he will work to try to get the money to be used within the City and is open to ideas from the members on how to use it. Lastly, Director Sassoon reported that the Hyperion perimeter road project is still ongoing and due to be completed in the Summer.

b. CABGN Update: Director Sassoon provided a status update regarding the 2<sup>nd</sup> year of the Cal Green Business Network program. He shared that the SBCCOG team has already certified 2 businesses and they are currently working on certifying one more. Member Butler stated that it has been difficult recruiting businesses to get certified as they don't see the benefits. He suggested having current green businesses give statements regarding the benefits they have received since becoming certified and use that to help promote the program. Director Sassoon added that SBCCOG will attend the City's Farmer's Market on 4/20/2022 to held get the word out about the green business network.

### 6. REPORTS: ENVIRONMENTAL COMMITTEE MEMBERS

a. Environmental Work Plan: Chair Miller-Zarneke tabled the item for next meeting due to time constraints.

The Department of Toxic Substance Control (DTSC) invites you to comment on the Draft RCRA-equivalent Hazardous Waste Facility Operating and Post-Closure Permit (Draft Permit) for the Chevron Products Company (Chevron), El Segundo Refinery, located at 324 West El Segundo Boulevard, El Segundo, California 90245 (Facility). The Draft Permit will allow Chevron to store and treat onsite generated hazardous waste and continue post-closure care activities in the Landfarm Area.

The Facility occupies approximately 1,000 acres in the City of El Segundo, adjacent to the City of Manhattan Beach. The permitted operating units are in the west-central portion of the Facility covering approximately one acre. The regulated post-closure unit is located near the south-eastern corner of the Facility covers approximately 9 acres.

Permit and Operations: Chevron have a current hazardous waste facility permit to conduct hazardous waste treatment, storage, disposal, and transfer activities at the Facility as required by the California Code



Department of Toxic Substances Control

of Regulations, title 22, division 4.5 and the California Health & Safety Code. The Draft Permit addresses active hazardous waste management units (HWMUs), and a post closure unit that ceased receiving waste in 1987 and which requires ongoing post-closure care. The post closure unit is a land treatment unit in the Landfarm Area. The active HWMUs are container storage and tank treatment and storage units. Treatment activities include neutralization (pH adjustment) in tanks.

Safety Measures: DTSC inspects hazardous waste treatment, storage, and disposal facilities on a regular basis to make sure facilities comply with Federal and California laws, and permit conditions. Most recently, DTSC inspected the Facility in 2010, 2012, 2013, 2016, 2018, 2020, and 2021. No violations were found in the 2010 to 2013 inspections. The 2016 inspection had one Class II and two minor violations for failure to make hazardous waste determinations, and to record inspections in an inspection log or summary sheet. The 2018 inspection had one Class II and four minor violations for failure to properly mark a hazardous waste container, to obtain the signature of the initial transporter and the date of acceptance, to submit an exception report, to certify the required information for waste shipped off-site, and to develop a schedule and procedure for assessing the tank condition. The 2020 and 2021 inspections had no violations.

California Environmental Quality Act (CEQA): DTSC must evaluate whether the Permit may have any significant impacts on human health and the environment. As part of this evaluation, DTSC prepared an Addendum to an adopted Negative Declaration in accordance with the requirements of CEQA, Public Resources Code section 21000 et seq. and the Guidelines for Implementation of CEQA, California Code of Regulations, title 14, section 15164. Upon making a permit decision, DTSC will file a Notice of Determination with the Office of Planning and Research State Clearinghouse.
