I want to highlight an ongoing safety concern at the crosswalk at Oak Main St. that requires immediate attention. Over the past eight years, we've witnessed numerous pedestrian accidents and near-misses at this intersection. This long standing issue poses a significant threat to our neighborhood's safety, especially given its role as a main crosswalk for high school and Richmond school students.

The heart of the problem lies in speeding vehicles on Main Street, and lack of clear visibility to this intersection along with the speeds at which drivers travel in this area endangers all pedestrians at this intersection.

I strongly urge the installation of a stoplight or at least a stop sign at this crosswalk. This step would force drivers to slow down, enhancing pedestrian safety and reducing accidents.

Please consider our plea during the city council meeting tomorrow. Our community's safety, particularly our students', is at stake.
