




Portfolio Through Time




Investments by Security Type







Reserve Portfolio Ladder by Quarter










LAIF Diagnostics As of July 2023


Rolling 13-Month Cash Flow Analysis



Net Change in Cash by Year





U.S. Treasury Yield Curve




U.S. Treasury Maturity Through Tlme
