**Subject:** Yadranka Draskovic is unsuitable for a DEI committe

Dear Esteemed Council Members and Mayor,

I'm writing with concern after learning you are going to interview Yadranka Draskovic for a position on the DEI committee. Ms. Draskovic celebrated a violent mob attack at a school board meeting in Glendale last year, in a social media post. I have attached her post to this email. This was particularly egregious to me because I was present at the event she posted about and covered it as a photojournalist.

Several women were punched in the head by Armenian Power gang members, and Proud Boys started a brawl that was so violent the school board meeting went on lockdown. Three people were arrested. (one pro LGBTQ supporter, and two far-right individuals. A man pepper-sprayed a clergyman in the face. Most protesters were not from the school district. It was an ugly day, and frankly, it's shocking that Ms. Draskovic would post anything but a condemnation of the violence, but she commented ***"This is what happens when parents get really upset and feel unheard"***. As a parent myself, I have never felt the need to riot, beat people, or shut down a school board meeting.

I have seen Yadranka consistently try to rile and divide our community, attacking schools, implying that teachers have a secret agenda to separate children from parents.

Yadranka Draskovic has made concerning anti LGBTQ comments. She is against DEI, so I do not understand the logic of putting her on a DEI committee unless you want to destroy it from within.

Yadranka believes there is an agenda to "sexualize" children in schools that is part of DEI, and believes it's some sort of communist plot. Her presence on any city committee or office will put residents in danger of discrimination and could lead to lawsuits for the city.

I am writing this quickly, but I will follow up with quotes from the two podcast interviews she did.
